### RESOLUTION

Motion by Vice Chairman Chupp seconded by Commissioner Miars that the following resolution be adopted:

WHEREAS, the St. Joseph County Road Commission whose address is 20914 M-86, Centreville, Michigan, 49032, quitclaims to White Pigeon Sanitary System, a Michigan body corporate, whose address is 16220 Indian Prairie Road, White Pigeon, MI 49099, the following described premises situated in White Pigeon Township, St. Joseph County, Michigan;

A part of the Southwest fractional Quarter of Section 2, Township 8 South, Range 11 West, White Pigeon Township, St. Joseph County Michigan described as:

A portion of Oak Street, from just north of the second sharp curve, north of US12, starting at the end of the present blacktop, then north 500 feet to Blanchard Street and northeast 820 feet on Blanchard Street.

WHEREAS, said petition has been determined to be a legal petition as required by Act 150 of the Public Acts of 1970,

WHEREAS, a public hearing was held pursuant to the law, to hear support or objections to the petitioned designation,

WHEREAS, after deliberating within thirty (30) days after said public hearing was held, the Board does hereby deem the designation desirable.

THEREFORE BE IT RESOLVED, That the Board of County Road Commissioners of the County of St. Joseph does here designate the above described portion of Oak Street (a/k/a/ Blanchard Street) in Section 1, R11W, T8S, of White Pigeon Township is no longer a Natural Beauty Road.
