ALL UTILITIES

Permits for ALL Telecommunications & Video Service Providers \$2,000,000 \$2,000,000

***Certificate of Insurance must include an Additional Insured Endorsement naming the Board of County Road Commission of the County of St. Joseph, the St. Joseph County Road Commission and its officers, agents, and employees as additional insureds for the appropriate period of time.**

ALL ROAD BEDS

\$2,000,000 \$2,000,000

If tearing up a road bed (traveled portion of the road) SJCRC must be an Additional Insured and both the applicant and contractor must provide COI.

***Certificate of Insurance must include an Additional Insured Endorsement naming the Board of County Road Commission of the County of St. Joseph, the St. Joseph County Road Commission and its officers, agents, and employees as additional insureds for the appropriate period of time.**

ALL ROAD SIDES only

If working on (road side) shoulders, ditches, etc. the contractor needs to provide their own insurance.

ALL DRIVEWAYS

Residential/Commercial/Farm/Field \$1,000,000 \$1,000,000
Residential driveways only the contractor needs to provide. Commercial/Farm/Field both the applicant and contractor must provide insurance.

OVERSIZED VEHICLES, LOADS or BUILDINGS

Must provide proof of no-fault insurance

Mobile Homes and Buildings under 14' wide – Single Move	n/a	100,000
Mobile Homes and Buildings over 14' wide – Single Move	n/a	300,000
Blanket Permit covering 4 or under vehicles	n/a	300,000
Blanket Permit covering 4 or more vehicles	n/a	500,000

SEASONAL PERMITS DURING SPRING WEIGHT RESTRICTIONS

Must provide proof of no-fault insurance.

Milk Haulers	n/a	500,000
Seasonal Blanket Permit to haul certain commodities during frost laws	n/a	500,000
Single Move Permit to haul certain commodities during frost laws	n/a	500,000

NOTE: The insurance should be provided by the applicant/owner unless a contractor is performing the work, in which case, only the contractor will furnish the insurance. Statutory worker's compensation coverage is also required if you have employees. If a Certificate of Insurance cannot be provided, a copy

of the policy will be accepted. All sub-contractors that perform work for prime contractors, utilities, or private individuals shall furnish proof of insurance in accordance with this schedule.

INSURANCE for Bidders of equipment

If awarded the bid, Bidder agrees to **indemnify and hold harmless the Board of County Road Commissioner of the County of St. Joseph, the St. Joseph County Road Commission and its officers, agents, and employees and furnish a proof of the Certificate of Insurance to the St. Joseph County Road Commission if working on the road bed.**
