APPROVAL BY BOARD OF COUNTY ROAD COMMISSIONERS OF THE COUNTY OF ST. JOSEPH FOR THE REQUESTED ROUTE ON THIS APPLICATION CONSTITUTES A PERMIT IN COMPLIANCE WITH SECTION 722, PUBLIC ACT 300 OF 1949, AS AMENDED UNDER THE FOLLOWING CONDITIONS AND RESTRICTIONS.

1. Permit must be carried in the vehicle.
2. Speed limit not to exceed 35 mph.
3. Normal legal loadings only.

(Applicant must sign on the back)

4. The Board of County Road Commissioners of the County of St. Joseph has the right to suspend this agreement if weather or road conditions warrant such action.
5. Any of the following actions shall immediately void the permit and subject the applicant to appropriate legal action:
  - a. Misrepresentation of information set forth in any application for permit;
  - b. Noncompliance with the conditions, restrictions, or provisions on which a permit is issued;
  - c. A change or erasure on a permit.
6. The permittee shall be responsible for damages to the highway, to persons, and to property caused by or arising from operations covered by this permit. The permittee shall indemnify and save harmless the St. Joseph County Road Commission, Board of County Road Commissioners of the County of St. Joseph, and all their employees from any and all suits, claims, and damages of every kind arising out of, under, or by reason of this permit, or from operations covered by this permit.
